### INFORMATION ON THE PROCESSING OF PERSONAL DATA

#### **Controller**

DEVELOG S.r.l. is not required to appoint a D.P.O. (Data Protection Officer) pursuant to art. 37 of the GDPR.

#### **Place of processing and recipient of personal data**

The processing connected to the personal data collected through this web site takes place on the premises of the Controller and are carried out only by technical personnel in charge of processing.

No data deriving from web services will be disseminated.

#### **Collected data**

[www.develop.eu](http://www.develop.eu) website collects personal data spontaneously entered by the Data Subject in the "On Going" form so that the user can ask for more information on the logistics areas and the projects in progress. The personal data collected are: name, e-mail, sender's message.

[www.develop.eu](http://www.develop.eu) website also collects personal data personally entered by the Data Subject in the "contacts" form such as: name, e-mail and text of the message written by the navigator, so that she/he can ask questions or get more information from DEVELOG company.



DEVELOG S.r.l. does not intend to process personal data of minors under the age of 16 and neither special categories of personal data art. 9 of the GDPR.

www.develog.eu website processes information and technical data necessary for correct navigation or aimed at the extraction of statistical data and verification or control about the correct functioning of the site and are periodically deleted also through automatic systems.

The data could be used to ascertain responsibility in the event of computer crimes against the site.

The optional, explicit and voluntary sending of e-mail to the e-mail address indicated on this site, implicitly expresses consent to the processing and entails the subsequent acquisition of the sender's address necessary to respond to requests, as well as any other personal data included in the message.

#### **Purposes of the processing**

Personal data are processed in order to respond to requests sent by the Data Subject. This treatment is optional, requires the consent of the Data Subject but allows DEVELOG S.r.l. to offer a better service. Consent must be expressed.

#### **Transfer of data to third countries**

The collected data can be processed at hosting services resident in non-EU countries, which are in any case compliant with art. 45 or offer the guarantees pursuant written in art. 46 of the GDPR.

#### **Duration of the processing**

The processing of personal data generated through cookies has a maximum duration of 2 years.

The statistical processing and the personal data sent through the "contacts" form, "on Going" form, or other direct method of the Data Subject do not have a term and can be processed only for internal archiving of the organization until the withdrawal of consent.

#### **Right of the data subject**

The user has the right to:

- withdraw consent at any time. The user can withdraw consent to the processing of his/her personal data previously expressed.

- oppose to the processing of his/her data. The user can object to processing of his/ her data when it takes place on a legal basis other than consent. Further details on the right to object are indicated in the section below.
- access his/her data. The user has the right to obtain information on the data processed by the Controller, on certain aspects of the processing and to receive a copy of the data processed.
- verify and request correction. The user can verify the correctness of his/her data and request its updating or correction.
- obtain the limitation of processing. When certain conditions are met, the user can request the limitation of the processing of his/her data. If so, the Controller will not process the data for any other purpose other than their conservation.
- obtain the cancellation or removal of his/her personal data. When certain conditions are met, the user can request the cancellation of his/her data by the Controller.
- receive his/her data or transfer them to another Controller. The user has the right to receive his/her data in a structured format, commonly used and readable by an automatic device and, where technically feasible, to obtain the transfer without obstacles to another Controller. This provision is applicable when the data are processed with automated tools and the treatment is based on subject's consent, on a contract of which the user is a party or on contractual measures connected to it.
- Propose a complaint. The user can lodge a complaint with the competent personal data protection control authority or take legal action.

The exercise of rights can be exercised simply by deleting cookies from device through the procedures of each browser. It's possible to write an email requesting information about the personal data stored by the Controller and requesting cancellation.

#### **Automated processes**

The data collected through cookies can be processed for the creation of anonymized statistics for the exclusive use of DEVELOG S.r.l..

## **USE OF COOKIES**

### **What are cookies?**

Cookies are small text files that the sites visited by users send to their terminals, where they are stored and then retransmitted to the same sites on the next visit. The cookies of the so-called "third party" are, instead, set by a Website other than the one the user is visiting. This is because on each site can be present elements (images, maps, sounds, specific links to web pages of other domains, etc.) that reside on servers other than that of the visited site.

### **What are cookies used for?**

Cookies can be used for different purposes: execution of computer authentication, monitoring of sessions, storage of information on specific configurations concerning users accessing the server, storing preferences, etc.

### **Cookie Policy**

### **Types of cookies used and related purposes**

- **Technical cookies**

These cookies, always sent by the domain [www.develog.eu](http://www.develog.eu), are necessary to correctly view the site and in relation to the technical services offered, they will therefore always be used and sent, unless the user changes the settings in the browser (thus affecting viewing the site pages).

Their use is not instrumental to the collection of personal identification data of users, but to improve navigation, such as returning to the same page if the internet connection is lost; or remember the preferences selected by the user while browsing, such as the language selected by the data subject for viewing the website.

- **Statistics**

***Google Analytics (Google Inc.)***

Google Analytics is a web analysis service provided by Google Inc. ("Google").

Google uses the personal data collected for the purpose of tracking and examining the use of this online space, compiling reports and sharing them with other services developed by Google.

Google may use personal data to contextualize and personalize the advertisements of its advertising network.
